INTRODUCTION

BlackBerry will assess the security assurance of the target software through an in-depth static analysis of software images.

The specific techniques employed will be tailored to the system being assessed, the strategy being to understand weaknesses in the software's security design by inspection of the binary, support and operating system files. BlackBerry will provide a walk-through of detailed dashboards showing statistics on software code quality and vulnerabilities.
